The regular meeting of the Walker Mayor and City Council was held at the Walker City Hall on Monday, May 13, 2024 at 6:00 p.m. The meeting was called to order by Mayor Jimmy Watson, followed by prayer led by Councilman, Richard Wales. Finance Director, Mike Cotton, presented to the council the March 2024 financial report. Total net profits for the period ending March 31, 2024 were \$2,283.084; sales tax increased 5% and gas revenue increased 17%.

City attorney, Bobby King, proclaimed the Proces Verbal of the Canvass of the Votes casted for the *Half-Cents Sales Tax* special election held on April 27, 2024 which declared there were 233 votes FOR the proposition and 106 votes AGAINST the proposition—339 total votes.

Thereafter, Mr. King presented before the Mayor and the members of the council the Resolution to Declare the Results of the Special Election Authorizing the Renewal of the Levy and Collection of One-Half of One Percent Sales and Use Tax for a period of twenty-five years beginning April 25, 2025.

Upon a motion made by Mr. Griffin, seconded by Mr. Cook, the resolution was approved as presented.
